

#### What is required to participate in WIC?

Proof of Identification Proof of Virginia Residency \*\*United States Citizenship is not required Proof of ALL Household Income

Income Eligibility is determined based on ALL household income. Income must be printed and cannot be older than 30-days old. Since LES are given on a monthly basis, the most recent months LES must be used. For any applicant/participant whose family contains any Active Duty Military household members, all gross income shall be counted EXCEPT for the following:

- BAH Basic Allowance for Housing
- FSH Family Separation Allowance
- OHA Overseas Housing Allowance
- OCONUS COLA Outside Continental United States Cost-of-Living Allowance
- Advance Pay
- Montgomery GI Bill salary reduction
- FSSA Family Subsistence Supplemental Allowance
- · Combat Pay Excluded in certain situations
- PAC Pay and Allowance Continuation
- DEIP Deployment Extension Incentive Pay

#### Annual Items on LES will be divided by 12 to obtain the monthly amount (i.e. Clothing Replacement Allowance)
